1.0 PROJECT OVERVIEW

1.1 Purpose of the Public Involvement Plan

The purpose of this Public Involvement Plan (PIP) is to describe a wide range of public outreach activities that will be implemented as part of the NH Route 108 Complete Streets Improvement Project (State Project No. 29604). This New Hampshire Department of Transportation (NHDOT) PIP will:

- Provide contact information for the Project Team;
- Provide a list of the members of the Project Working Group;
- Explain the NHDOT Project Development Process;
- Communicate upcoming meeting dates and overall project schedule;
- List anticipated communication products and methods;
- Keep all interested stakeholders and the public-at-large well informed of the project status and activities; and
- Provide timely, useful, current information through a variety of targeted means and methods.

This PIP will be revised periodically to reflect updates to the project meeting dates and locations, project schedule and other salient items that may change over the course of this multi-year project. This PIP will not be considered a complete document until the end of this phase of the project, which is the Preliminary Design.

1.2 Project Description

This project proposes improvements to NH Route 108 from the intersection of NH Route 9/Indian Brook Drive in Dover to Innovation Drive in Rochester, a distance of approximately 5 miles (see Figure 1 below). NH Route 108 is generally two lanes with variable width shoulders through the project area. Localized improvements have been made in recent decades at key intersections and some commercial developments to add turning lanes, shoulders, and traffic signals. However, safety and mobility issues remain a concern. Specific concerns include the following:





- The corridor is subject to very high peak period traffic, which restricts mobility particularly in the vicinity of key intersections.
- The lack of consistent shoulders or sidewalks hinders the mobility of non-motorized users.
- The lack of formal bus stops creates safety concerns for the patrons of COAST Bus, and buses stopped within the highway further hinder mobility.

The objective of the project is to develop an alternative that will improve the safety and mobility of all users by applying 'Complete Street' principles with the central goal of achieving an appropriate balance between the needs of motorized, non-motorized, and transit users of the corridor. The three cities of Dover, Somersworth, and Rochester, in cooperation with the Strafford Regional Planning Commission, have formed a NH Route 108 Complete Streets Working Group to provide local perspective on the needs within the corridor. The Working Group will help define the project's purpose and need and guide the alternatives analysis as the project moves forward.

Corridor alternatives will be developed based on the results of the traffic study that is currently underway. The need for widening is assumed. However, the extent of widening has not yet been determined and will depend upon the number of additional lanes needed to meet current and future traffic demands.


In addition to overall corridor improvements, specific intersections will be studied to determine appropriate safety and capacity improvements, which could consist of signalized or roundabout control. These key intersections are listed below:

- NH Route 108/NH Route 9/Indian Brook Drive
- NH Route 108/Hotel Drive/Willand Pond Road
- NH Route 108/Long Hill Road
- NH Route 108/Blackwater Road
- NH Route 108/Whitehouse Road/West High Street (NH Route 236)
- NH Route 108/Innovation Drive

2.0 PROJECT PROCESS

2.1 NHDOT Project Development Process

The project is following the standard NHDOT project development process. The project is currently in the Preliminary Design phase, during which project design alternatives will be developed and analyzed for impacts. At the conclusion of the analysis, a recommended alternative will be identified and presented to the public. Environmental documentation will occur in the form of a Categorical Exclusion and Section 4(f) Evaluation, pursuant to the National Environmental Policy Act (commonly referred to as NEPA). Preliminary Design will be complete when the recommended alternative is presented to the public at a formal Public Hearing.

After the completion of Preliminary Design, the next phase of the project will be Final Design, during which final engineering plans will be developed, right-of-way/easements will be acquired as needed, and construction contract documents will be prepared. Final Design is complete when the project is advertised for construction bids and is awarded to a contractor. The start of construction is based upon available funding, contractor schedule, and weather, but the first phase of construction is tentatively scheduled for 2027. Construction is anticipated to span multiple seasons and include several construction contracts.

2.2 Project Meetings

The NHDOT will hold a series of meetings with the public-at-large, local officials, public agencies, transportation and transit agencies, private transportation providers and other stakeholders. The overall purpose of these meetings will include:

- Introducing the project;
- Disseminating information within the three communities and provide a setting for discussion and gathering feedback that will help form the alternatives and impacts;
- Complying with the NEPA process which calls for public involvement during the process
 of evaluating the environmental, social, economic and cultural resource impacts from the
 project.
- Presenting and describing the potential alternatives and associated impacts of each;





- Providing adequate opportunity for public comments and public involvement throughout the multi-year process; and
- Addressing concerns of the public, officials, agencies and stakeholders.

The meetings will be open to all members of the public and are anticipated to consist of the following, in these general categories:

- Public Listening Sessions: The focus is to kick-off the project with members of the public, commuters and the three communities for the purposes of receiving feedback on all matters of concern or interest.
- Working Group Meetings: The focus is to discuss detailed aspects of the project design alternatives and solutions and to understand the specific needs of the three communities, the Strafford Regional Planning Commission, and COAST Bus.
- Public Officials Meetings: The focus of these meetings is to engage and inform the elected officials, city staff, the members of the city boards, and other interested members of the public about the details of the project. These meetings may entail a formal presentation to the elected officials. These meetings (or presentations) will be held throughout the project duration.
- Public Informational Meetings: The focus of these meetings is to engage and inform the general public within the three cities about the details of the project and receive feedback. The meetings will be held throughout the project duration.
- Walking Tours: The focus is for the public to discuss areas of concern or areas of interest on-site with members of the project team.
- Public Hearing: The purpose of the Public Hearing is to inform the public of the recommended design alternative. This hearing serves to meet the requirements of the NHDOT public information process and the necessity of the layout of the proposed action.

The status and general timeframe of the anticipated public meetings are detailed below. Materials presented will be available on the project website.
